



Mid Hills Netball Association Carnival Committee

Player Responsibilities

Players selected in the MHNA Representative Teams shall:

1. Play in the MHNA Summer competition with their allocated Association Rep Team **ONLY**
2. Attend Carnivals as nominated by the Carnival Committee with the Mid Hills Carnival and SA Country Championships being compulsory.
3. Notify your Coach if you are unable to attend a carnival or training session due to illness, injury, or other valid reason as soon as possible.
4. Attend all training sessions arranged by your Coach - inclusive of training camp. Carry out all the trainings as set by the Coach.
5. Be aware court time during minor rounds, will be equal, as near as practicable, with the games played at the discretion of the coach throughout the carnival. Game time in finals is at the discretion of the coach.
6. Be courteous and respectful to all team members and officials.
7. Complete a Medical Form and Media Consent Form return it to the Team Manager/Coach at uniform try on day/before camp
8. Pay fees as invoiced by the due date or as negotiated.
9. Wear the full uniform, as approved by the Mid Hills Association whilst attending all carnivals.
10. Supply strapping and medical supplies for existing injuries.
11. Attend the Mid Hills Rep Team Presentation if held.
12. Support fund raising activities on behalf of the Rep Teams
13. Return uniform in good condition and timely manner as requested.
14. There is No Smoking, vaping or being under the influence of alcohol or any illicit substances in any official netball area.
15. Be aware of qualifications for Country Championships. A minimum of 3 part games must be played for your club, prior to the June long weekend.



Mid Hills Netball Association Carnival Committee

A selected player may be subject to replacement should they;

- Not meet the above obligations, or
- Not meet playing standards, or
- Not provide a medical certificate when requested for absence due to injury or illness.

The Carnival Committee shall meet to discuss any concerns with the Coach and any player subject to possible replacement. Should a replacement be deemed necessary, that player will be taken from the reserve's list in the first instance.

If a player withdraws, the player cannot play for any other Mid Hills Representative Team during that Representative season.

MHNA Representative Teams must agree to the following conditions:

- *To abide by the Constitution and By Laws and Rules of the Association.*
- *To assist in public relation activities when requested by MHNA Carnival Committee*
- *To conduct myself in a manner befitting as an Ambassador for the Association*
- *At all times to act and compete in a sporting manner both on and off the court,*
- *To accept that, I am to consider myself a promoter of netball and an ambassador for the Association.*
- *I agree to comply with the uniform requirements as directed by MHNA Carnival Committee.*
- *I agree to pay the expenses as determined by the MHNA Carnival Committee.*
- *The following MHNA By-Laws and Rules also apply R11 and R12 .*
- *I accept that any breach of this agreement will be handled by MHNA Carnival Committee who will then report to the MHNA Board of Management.*
